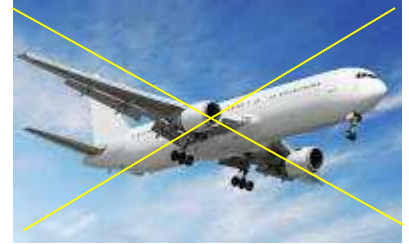

5. In accordance to [South African Companies Act](#), every South African company must appoint a public officer. The Public Officer must be a tax resident individual. Most of our clients appoint one of the local staff members as public officer. If required, Healy Consultants Group PLC will be pleased to be appointed as public officer for our Client's firm. Our fee for the same amounts to US\$2,950 per annum;
6. For an active trading company, these [accounting and tax](#) fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants Group PLC will more accurately advise accounting and tax fees. 15. Depending on our Client's business and nationality, the South African Government may require a special regulatory license to carry on your business in the country. However, the Government enjoys ultimate power of approval of company registrations and business licenses;
