Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. Healy Consultants Group PLC will act as your Montenegro Company Secretary, for which our annual responsibilities include **i)** preparation and filing of the annual return; **ii)** securely maintaining company records; **iii)** liaising with the Montenegro Government on behalf of our Client; **iv)** legal filing of changes of company structure; and **v)** ensuring company record compliance with local company law and **vi)** reminding our Client of statutory deadlines;;

In accordance with Montenegro [Law on Business Organizations](#), a limited liability company shall as from the date of its incorporation have a legal registered office in Montenegro, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group PLC' Montenegro office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including including **i)** tax letters **ii)** notice of the legal annual return; and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants Group PLC' office address](#) on invoices, contracts, websites and business cards;

3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** reserving the company name **ii)** paying the Company Registry name **ii)** notarizing all company documents and **iii)** registering our Client for with and Pension at Tax Administration counter **iv)** obtain company seal. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;

Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;

5. In accordance with Montenegro law, every Montenegro company with annual revenue in excess of €18,000 must be registered for VAT. Healy Consultants Group PLC will be happy to assist you with tax and VAT registration with the [Ministry of Finance](#) for a one time fee of €750;
6. For an active trading company, these [accounting and tax](#) fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants Group PLC will more accurately advise accounting and tax fees. For a dormant company, Healy Consultants Group PLC fees are only €950;
7. All fees quoted in this invoice correspond to fees quoted [on Healy Consultants Group PLC' website](#). Please review this invoice carefully to identify errors. 

Our fee to be both non-resident nominee director and shareholder amounts to US\$6,600 per annum.
