1. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed company, when shareholders and directors reside overseas. There is a 30% probability the banks will request a bank signatory to travel for a one hour bank interview. Healy Consultants Group PLC will try its best to negotiate with the bank for a travel exemption. If our Client must travel for corporate bank account opening, Healy Consultants Group PLC will refund our Client €950;



6. In accordance with Netherlands Law, all Netherlands companies must register for corporate tax and VAT at the [Netherlands Tax and Customs Administration](#);
7. For an active trading company, these [accounting and tax](#) fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants Group PLC will more accurately advise accounting and tax fees. For a dormant company, Healy Consultants Group PLC fees are only €950;
8. All fees quoted in this invoice correspond to fees quoted [on Healy Consultants Group PLC' website](#). Please review this invoice carefully to identify errors. 12. In accordance with the [2012 Flex Act](#), limited liability companies in Netherlands are not subject to a minimum amount of issued share capital. However, banks will require a minimum deposit of approximately €4,000 to proceed with Netherlands corporate bank account opening;
13. In accordance with Dutch guidelines, it is not mandatory for a Netherlands limited liability company to have a director ordinarily resident in Netherlands. However, Dutch limited liability companies without a majority of EU resident directors will not benefit from Netherlands' Double Taxation Avoidance (DTA) treaties. If required, Healy Consultants Group PLC will be pleased to provide your firm with a professional nominee director in Netherlands. Our fee amounts to €6,600 per annum;
14. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients will **not** have to travel during this engagement. Healy Consultants Group PLC will efficiently and effectively complete company registration and corporate bank account opening in a timely manner without our Client presence. Instead, our Client will need to **i)** sign and get documents legalized in the embassy in their country of origin and **ii)** courier the originals to Healy Consultants Group PLC office;
