1. Healy Consultants Group PLC fees to efficiently and effectively complete Botswana company registration within [ten weeks](#) (click link) by **i)** choosing the optimum regulatory license for our Client's business activities **ii)** reserving a company name with [Registrar of Companies](#) **iii)** settling our accountant and lawyer fees and **iv)** preparing a high quality company incorporation application for [Ministry of Trade & Industry](#);

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a [detailed project plan](#), mapping out [deliverables](#) by week throughout the engagement term;

If required, Healy Consultants Group PLC will be pleased to provide your firm with a professional nominee director in Botswana. Our fee for a country resident director or shareholder amounts to US\$6,600 per annum;

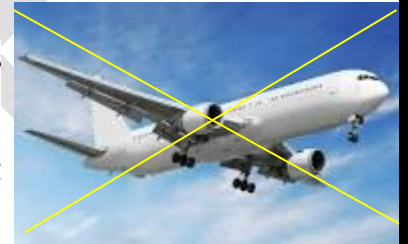

14. It is compulsory for every Botswana LLC to appoint an authorized auditor. To minimize complexity, Healy Consultants Group PLC recommends our Client appoint one staff member already in Botswana. If our Client is uncomfortable or unable to adopt this strategy, Healy Consultants Group PLC can contact audit firms on behalf of our Client;
15. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients' will ***not*** have to travel during this engagement.
