1. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. Thereafter, this address will be used to receive government correspondence including **i)** tax letters **ii)** notice of the legal annual return; and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants' office address](#) on invoices, contracts, websites and business cards;
3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** JSC company name reservation; **ii)** registration at the [Hungarian Registration Court](#) and **iii)** social security registration. Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;

What is inside our control is the preparation and submission of a high quality bank application that maximizes the likelihood of approval. 

5. In accordance with [Act LXXIV from 1992 On Value Added Tax](#), each entity must register for corporate tax and VAT at the [Hungarian Tax and Customs Administration](#);
 6. For an active trading JSC company, these [accounting and tax](#) fees are an estimate of Healy Consultants fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants will more accurately advise accounting and tax fees. For a dormant JSC company, Healy Consultants fees are only €950;

15. In accordance with the Corporate Taxation Act, all Hungarian JSCs are required to **i)** have their balance sheet and annual financial statements audited by a certified accountant and **ii)** file them with the company register every year.
16. If required, Healy Consultants will be pleased to assist your firm secure employee [visa](#) approvals. Our fee is €4,950 for the first employee, €2,950 for the second employee, €1,950 per employee thereafter. Our employee visa fees includes preparation of a quality visa application and submitting to the correct Government immigration officers. The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality immigration visa application that maximizes the likelihood of visa approval;
17. Some of our Clients request Healy Consultants to provide temporary shared [office space](#) for 6 months until their preferred business premises is found. If your Firm requires this service, our one-time fee is €950. Monthly rental thereafter is paid directly to the landlord, independently of Healy Consultants;

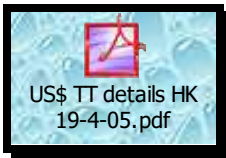
