1. Healy Consultants Group PLC's fees to efficiently and effectively complete Bahamas PLC registration within [two weeks \(click link\)](#) by **i)** choosing the optimum regulatory license for our Client's business activities reserving a company name with [the Corporate Registry](#); **ii)** settling our accountant and lawyer fees; and **iii)** preparing a high quality company incorporation application for the Registrar General Department;

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a [detailed project plan](#), mapping out [deliverables](#) by week throughout the engagement term;

In accordance with [Bahamas Companies Act 1992](#), each Bahamas PLC must appoint a local agent, who may be a natural person or a body corporate, but the company secretary must be resident in Bahamas. Healy Consultants Group PLC will act as your Bahamas registered agent, for which our annual responsibilities include **i)** preparing and filing the legal annual return; **ii)** securely maintaining company records; **iii)** liaising with the Bahamas government on our Client's behalf; **iv)** legal filing of changes of company structure; and **v)** reminding our Client of statutory deadlines;

In accordance with Bahamas law, an PLC shall as from the date of its incorporation have a legal registered office in Bahamas, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group PLC's Bahamas office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including **i)** tax letters **ii)** notice of the legal annual return; and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants Group PLC's office address](#) on invoices, contracts, websites and business cards;

3. This fee is an estimate of government costs payable during your Firm's engagement. All government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** reserving the company name and **ii)** file the company documents at the Companies Registry. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;
4. Healy Consultants Group PLC will be pleased to open a Bahamas corporate bank account without our Client travel. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed PLC when shareholders, directors and bank signatories reside overseas. Depending on our Client's business and nationality, there is a 20% probability the banks will request a bank signatory to travel for a one-hour bank interview. If our Client must travel for corporate bank account opening, Healy Consultants Group PLC will refund our Client US\$950;

Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;

What is inside our control is the preparation and submission of a high-quality bank application that maximizes the likelihood of approval. 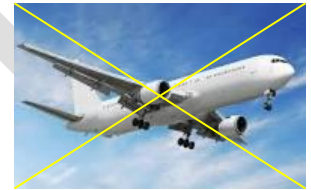

Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;

5. For an active trading company, these [accounting and tax](#) fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants Group PLC will more accurately advise accounting and tax fees. For a dormant company, Healy Consultants Group PLC fees are only US\$950;
6. All fees quoted in this invoice correspond to fees quoted [on Healy Consultants Group PLC's website](#). Please review this invoice carefully to identify errors. 10. In accordance with the [Companies Act 1992](#), there is no minimum share capital required for a Bahamas PLC company;

11. In accordance with the [Companies Act 1992](#), every Bahamas PLC shall have at least three directors. If our Client requires non-resident nominee shareholder and director [services \(click link\)](#), Healy Consultants Group PLC will be pleased to assist. Our fee for professional, passive nominee corporate shareholder amounts to US\$2,100 per annum. Our fee to be both nominee director and shareholder amounts to US\$6,600 per annum. Being the sole shareholders and sole director of a Client's company exposes Healy Consultants Group PLC to reputation, litigation and financial risk;
12. In accordance with [Bahamas Fiscal Code](#), VAT registration is compulsory for companies with Bahamas derived annual turnover exceeding US\$100,000; Bahamas Corporations with no local sourced income do not need to file income tax or VAT returns. If required Healy Consultants Group PLC will be happy to register your Bahamas company for income tax and VAT for a one-time fee of US\$950;
13. Depending on our Client's business and nationality, the Bahamas Government may require a special regulatory license to carry on your business in the country. Healy Consultants Group PLC will assist our Client secure license approval; there may be additional engagement fees. However, the Government enjoys ultimate power of approval of company registrations and business licenses;
14. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients will **not** have to travel during this engagement. Healy Consultants Group PLC will efficiently complete representative office registration and corporate bank account opening in a timely manner without our Client's presence. Instead, our Client will need to **i)** sign and get documents legalized in the embassy in their country of origin; and **ii)** courier the originals to Healy Consultants Group PLC's office;
15. If required, Healy Consultants Group PLC will be pleased to assist your firm to secure employee [visa](#) approvals. Our fee is US\$2,950 for the first employee, US\$1,950 for the second employee, US\$950 per employee thereafter. Our employee visa fees includes preparation of a quality visa application and submitting to the correct Government immigration officers. The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants Group PLC's control. What is inside our control is the preparation and submission of a high quality immigration visa application that maximizes the likelihood of visa approval;
16. Monthly and quarterly Government tax obligations include monthly and quarterly VAT return filing for Bahamas sourced income. If you need our help, Healy Consultants Group PLC can complete monthly Government reporting for a monthly fee of US\$860. Healy Consultants Group PLC monthly support will include **i)** receive in Dropbox the monthly invoices from our client; **ii)** label monthly bank statement transactions; and **iii)** preparation and submission of VAT returns;
