1. Healy Consultants fees to efficiently and effectively complete Chad company registration within [4 months](#) by **i)** choosing the optimum regulatory license for our Client's business activities **ii)** reserving a company name with the clerk's office of the Commercial court **iii)** settling our accountant and lawyer fees and **iv)** preparing a high quality company incorporation application for [Ministry of Commerce and Industry](#);

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a [detailed project plan](#), mapping out [deliverables](#) by week throughout the engagement term;



Every week during the engagement, Healy Consultants will email our Client a [detailed status update](#). Our Client is immediately informed of engagement problems together with solutions. To comply with this statutory requirement, Healy Consultants' Chad office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including **i)** tax letters **ii)** notice of the legal annual return; and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants' office address](#) on invoices, contracts, websites and business cards;
3. This fee is an estimate of Government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** reserving the company name **ii)** notarizing company's deeds and memorandum and articles of association with the Registrar of Companies **iii)** registration with the [Service d'Enregistrement des Domaines et du Timbre](#), **iv)** register with the different departments such as [National Agency for Investment and Exports \(ANIE\)](#) **v)** register with the [Ministry of Commerce and Industry](#) **vi)** advertise on a local newspaper the application for a trade and business license and **vii)** submission of the Internal Regulation Code to the Labour Inspection Office;

What is inside our control is the preparation and submission of a high quality bank application that maximizes the likelihood of approval. 5. In accordance with [OHADA](#) law, each entity must register for corporate tax and VAT at the [Ministry of Finance](#);
6. For an active trading company, these [accounting and tax](#) fees are an estimate of Healy Consultants fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants will more accurately advise accounting and tax fees. For a dormant company, Healy Consultants fees are only US\$950;
7. All fees quoted in this invoice correspond to fees quoted [on Healy Consultants' website](#). Please review this invoice carefully to identify errors. During the rush of the business day, it is possible that Healy Consultants inadvertently made fee calculation errors, typing errors or omitted services or omitted historic fee payments from Clients. 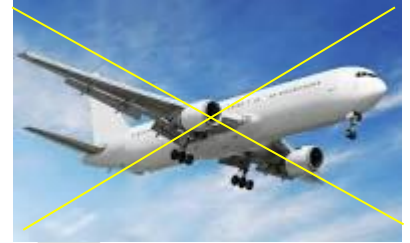

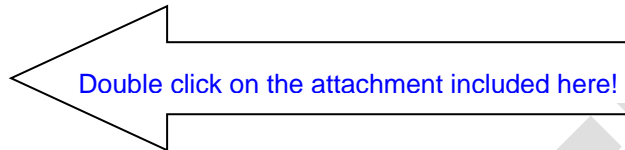
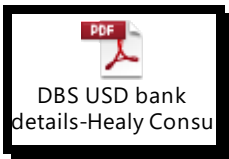
