Guinea, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants' Eq. Guinea office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including **i)** tax letters **ii)** notice of the legal annual return; and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants' office address](#) on invoices, contracts, websites and business cards;
3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** reserving the foreign company name; **ii)** obtaining the certificate of registration with the Companies Registry; **iii)** publishing the company's notice of commencement of operations in the Official Gazette; **iv)** obtaining the Tax Identification Number (NIF) and **v)** applying for an operating license. Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;

The banks enjoys ultimate power of approval of corporate bank account applications. Consequently, guaranteed success is outside of Healy Consultants' control. For an active trading company, these [accounting and tax](#) fees are an estimate of Healy Consultants fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants will more accurately advise accounting and tax fees;

In accordance with Equatorial Guinea regulations, all foreign-owned Equatorial Guinea LLCs must have **i)** 35% of their shares held by Equatorial citizens and **ii)** one third of their directors must also be Equatorial Guinea citizens. Consequently, most of our Clients prefer to register a branch of their foreign business in Equatorial Guinea. Before doing so, Healy Consultants recommends our Clients to settle a [retainer fee](#) to confirm whether branching will be legally allowed in the industry of operation of their business. Alternatively, Healy Consultants Group PLC can assist our Clients find [nominee shareholders and directors](#) to meet the above requirement, for a one-time fee of US\$4,950. Thereafter, our Client will directly pay to his preferred nominee(s) an annual fee;
13. In accordance with [Equatorial Guinea Commercial Code](#), the issued share capital of US\$20,000 (FCFA10 million) must be deposited to the company bank account prior to incorporation. To optimize engagement efficiency and minimize delays, Healy Consultants is happy to deposit these funds on behalf of our clients;
14. If our Client and Healy Consultants properly plan this engagement, our Clients' will **not** have to travel during this engagement. Healy Consultants will efficiently and effectively complete company registration and corporate bank account opening in a timely manner without our Client presence. Instead, our Client will need to **i)** sign and get documents legalized in the embassy in their country of origin and **ii)** courier the originals to Healy Consultants office;
