1. 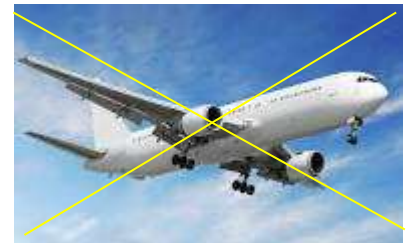

If required, Healy Consultants Group PLC will be pleased to provide your firm with a professional nominee shareholder from Qatar. Our fee for this service amounts to US\$41,320 per annum;
11. In accordance with [Qatar Commercial Companies Law No\(5\) of 2002](#), the issued share capital of US\$55,000 must be deposited to the company bank account before company incorporation is complete. To optimize engagement efficiency and minimize delays, Healy Consultants Group PLC is happy to deposit these funds on behalf of our clients;
12. The fees quoted in this invoice are a prediction of the fees required to efficiently and effectively complete this engagement in a timely manner. If during the engagement Healy Consultants Group PLC realizes that the project is more complex than anticipated, requiring a large additional investment of time, my Firm will revert to request additional fees.
