1. Healy Consultants fees to efficiently and effectively complete Bulgaria company registration within [two weeks \(click link\)](#). by **i)** choosing the optimum regulatory license for our Client's business activities; **ii)** reserving a company name with the [Trade Register](#) **iii)** settling our accountant and lawyer fees and **iv)** preparing a high quality company incorporation application with the [Trade Register](#);

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a [detailed project plan](#), mapping out [deliverables](#) by week throughout the engagement term;



Every week during the engagement, Healy Consultants will email our Client a [detailed status update](#). Our Client is immediately informed of engagement problems together with solutions. Your dedicated engagement manager is reachable by phone, Skype, live chat and email and will communicate in your preferred language;

In accordance with [Bulgaria Commerce Act 1991](#) (click link), each Bulgaria LLC shall as from the date of its incorporation have a legal registered office in Bulgaria, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants' Bulgaria office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including **i)** tax letters **ii)** notice of the legal annual return; and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants' office address](#) on invoices, contracts, websites and business cards;
3. This fee is an estimate of Government costs payable during your Firm's engagement. All Government fee payments will be supported by original receipts and invoices. Examples of Government costs include **i)** company name application with the [Trade Register](#) of the BCCI; **ii)** preparation of company deeds and **iii)** paying the BCCI business registration fee;. Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;
4. In accordance with the [VAT Law 2006](#) it is compulsory for companies that deal with commerce or services that are subject to VAT in Bulgaria to register with the [National Payments Agency](#) if their annual turnover exceed €25,000;

5. Healy Consultants will be pleased to open a Bulgaria corporate bank account without our Client travel. It is a time consuming task, and Healy Consultants will shelter our Client from the associated administrative challenges. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed company when shareholders, directors and bank signatories reside overseas. Healy Consultants will prepare a business plan for the bank to optimize the probability of corporate bank account approval. Depending on our Client's business and nationality, there is a 20% probability the banks will request a bank signatory to travel for a one-hour bank interview. Healy Consultants will try its best to negotiate with the bank for a travel exemption. If our Client is not comfortable with only a Bulgaria corporate bank account, Healy Consultants will be pleased to open [an international corporate bank account](#) (click link) outside of Bulgaria. Examples include New York, Germany, Liechtenstein, Austria, Bulgaria, South Africa, Australia, London, South America or Dubai. All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;

The banks enjoy ultimate power of approval of corporate bank account applications. Banks still regard cryptocurrency as a high-risk investment, therefore many banks are still uninclined to open bank accounts for companies dealing with Bitcoins. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high-quality bank application that maximizes the likelihood of approval. To date, we enjoy a 100% approval record because of our global banking relationships and determination;


Global banks continue to tighten corporate bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;

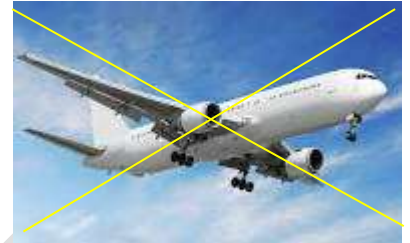
13. Depending on our Client's business and nationality, the Bulgarian Government may require a special regulatory license to carry on your business in the country. Healy Consultants will assist our Client secure license approval; there may be additional engagement fees. However, the Government enjoys ultimate power of approval of company registrations and business licenses;

14. If our Client and Healy Consultants properly plan this engagement, our Clients' will ***not*** have to travel during this engagement.
