1. Healy Consultants fees to efficiently and effectively complete Qatar wholly foreign owned company (WFOC) registration within [3 months](#) by **i)** choosing the optimum regulatory license for our Client's business activities **ii)** reserving a company name with [Ministry of Economy and Commerce](#) **iii)** settling our accountant and lawyer fees and **iv)** preparing a high quality company incorporation application for [Ministry of Economy and Commerce](#);

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a [detailed project plan](#), mapping out [deliverables](#) by week throughout the engagement term;



Every week during the engagement, Healy Consultants will email our Client a [detailed status update](#). Our Client is immediately informed of engagement problems together with solutions. 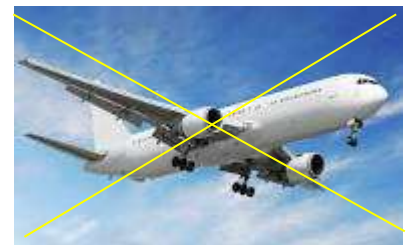

These sectors include **i)** science and technology sector **ii)** financial centers **iii)** financial markets **iv)** telecommunications **v)** information technology and **vi)** foreign consultancy;
12. In accordance with [Qatar Commercial Companies Law No\(5\) of 2002](#), the issued share capital of US\$55,000 must be deposited to the company bank account before company incorporation is complete. To optimize engagement efficiency and minimize delays, Healy Consultants is happy to deposit these funds on behalf of our clients;
13. The fees quoted in this invoice are a prediction of the fees required to efficiently and effectively complete this engagement in a timely manner. If during the engagement Healy Consultants realizes that the project is more complex than anticipated, requiring a large additional investment of time, my Firm will revert to request additional fees. If Healy Consultants completes the engagement faster and more easily than expected, Healy Consultants is happy to refund some fees to our Client;

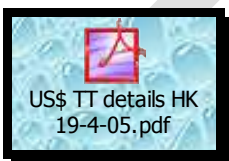
