1. All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. If our Client must travel to the States for free zone corporate bank account opening, Healy Consultants Group PLC will refund our Client US\$950;

If our Client is not comfortable with only a US free zone corporate bank account, Healy Consultants Group PLC will be pleased to open [an international free zone corporate bank account](#) (click link) outside the country. Examples include Germany, Liechtenstein, Austria, Bulgaria, South Africa, Australia, London, South America or Dubai. All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;

Healy Consultants Group PLC will prepare a business plan for the bank to optimize the probability of free zone bank account approval. However, the banks enjoy ultimate power of approval of corporate bank account applications. Consequently, guaranteed success is outside of Healy Consultants Group PLC's control. What is inside our control is the preparation and submission of a high-quality bank application that maximizes the likelihood of approval. To date, we enjoy a 100% approval record because of [our global banking relationships](#) and determination;

Global banks continue to tighten free zone corporate bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up at least 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;



5. In accordance with [Internal Revenue Service \(IRS\)](#) guidelines, each entity must register for tax by applying for an [Employee Identification Number \(EIN\)](#). Furthermore, all companies which wish to sell tangible property in Delaware must [register for gross receipts tax](#);
  6. For an active trading free zone company, these [accounting and tax](#) fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual free zone company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your free zone company, Healy Consultants Group PLC will more accurately advise accounting and tax fees. For a dormant free zone company, Healy Consultants Group PLC fees are only US\$950;
- In accordance with [Delaware Corporate taxation Laws](#), a Delaware LLC can either choose its income to be taxed at company level or have the same pass through to company shareholders (similar to a LLP). Regardless, an LLC entity annual tax return must be submitted to the IRS; reporting **i)** annual net profits; **ii)** member allocation of profit and losses and **iii)** balance sheet assets and liabilities;
7. All fees quoted in this invoice correspond to fees quoted on Healy Consultants Group PLC's website. Please review this invoice carefully to identify errors. During the rush of the business day, it is possible that Healy Consultants Group PLC inadvertently made fee calculation errors, typing errors or omitted services or omitted historic fee payments from Clients. In the unfortunate event you identify invoice errors, please revert to me directly re the same. I apologize in advance if I or my staff made invoice errors;

11. In accordance with [Delaware Company Code](#), there is no minimum share capital amount mandated for Delaware free zone company incorporation. However, you may be required to deposit share capital to secure the free zone operating permit. The amount of capital deposited will depend on your preferred business activity;
12. If required, Healy Consultants will be pleased to assist your Firm draft a feasibility study and an environmental impact study. Before confirming approval for registration of the free zone company in the applicable zone, the Zone authorities may require our Client to provide **i)** a feasibility study and **ii)** an environmental impact study (EIS) for their manufacturing investment project. To complete the same, Healy Consultants will **i)** prepare a quality business plan to secure confirmation of interest from multiple zones and thereafter **ii)** prepare and submit a quality feasibility study and EIS to our Client's preferred zone. After review of the documents, the zone authority will also confirm business setup capital including **i)** exact type of foreign certificate required; **ii)** paid-up capital required to secure the same and **iii)** manufacturing permits and licenses to be secured;
13. Depending on the specific nature of the business of our Client, the Delaware free zone authorities can require our Client to obtain a manufacturing license before our Client is legally allowed to commence manufacturing operations. If needed, Healy Consultants will be happy to assist our Client to **i)** prepare and collate all the required due diligence documents; **ii)** obtain and prepare all the required application forms and **iii)** submit a quality manufacturing license application with the relevant authority. Additional fees will apply for these services;
14. If our Client requires nominee shareholder and director [services \(click link\)](#), Healy Consultants Group PLC will be pleased to assist. Our fee for professional, passive nominee corporate shareholder amounts to US\$2,100 per annum. Our fee to be both nominee director and shareholder amounts to US\$6,600 per annum.
