Notes to invoice above

1. Healy Consultants Group PLC's fees to legally register our Client's South Korea LLC with our temporary professional, passive nominee [shareholders and directors](#) and bank signatory. Within [2 weeks](#), my team and I will email you **i)** a company registration number **ii)** a corporate bank account number **iii)** a city centre business address **iv)** a tax number and **iv)** a proforma South Korea sales invoice template complying with South Korea company law;

Within [2 weeks](#), our Client can legally conduct business in South Korea; including **i)** issue sales invoices to local customers **ii)** sign customer and supplier contracts **iii)** sign a lease agreement for long term physical office and warehouse premises **iv)** and hire local and expatriate employees including secure employment visa approval;

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees or surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of [a detailed project plan](#), mapping out deliverables by week throughout the engagement term.



Every week during the engagement, Healy Consultants Group PLC will email our Client a [detailed status update](#). Our Client is immediately informed of engagement problems together with solutions. If our Client is not comfortable with only a South Korea bitcoin corporate bank account, Healy Consultants will be pleased to open [an international corporate bank account](#) (click link) outside of South Korea. Examples include New York, Germany, Liechtenstein, Austria, Bulgaria, South Africa, Australia, London, South America or Dubai. All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;

The banks enjoys ultimate power of approval of bitcoin bank account applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality bank application that maximizes the likelihood of approval.



Global banks continue to tighten bitcoin corporate bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take at least 5 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;

Because of the nature of our Client business, there is 65% probability the banks will revert requesting additional information from the Client, including **i)** due diligence on the shareholders and directors; **ii)** proposed transactions of the company; **iii)** expected funds to be received into the bank account. Additionally, there is 35% probability the bank in-house Legal and Compliance Department will reject your bitcoin corporate bank account application. In the unfortunate event this occurs, Healy Consultants will immediately discuss alternative corporate bank account [solutions \(click link\)](#); Furthermore, Healy Consultants expects the bank's risk department to request additional [due diligence](#) from our Client's business including **i)** specific license; **ii)** proof of business globally and **iii)** additional KYC information on our Client's business and place of residency. We assume our Client provides most of this information within one week;

Depending on our Client's business and nationality, there is a 45% probability the bank officer will request a set of corporate documents to be certified by the local registered agent, apostilled, translated or legalized with the nearest South Korean Embassy. In such case, Healy Consultants estimates the bitcoin corporate bank account opening will be delayed with up to two business weeks. Following appropriate attestation of signatures, bank due diligence and corporate bank account opening forms, our Client couriers signed corporate bank account opening set required by the bank to our preferred address;

In late 2017, the Korea Government has also restricted cryptocurrencies transactions, notably those requiring international transfers. Consequently, our Client should expect to meet unexpected challenges and extra KYC requirements when remitting abroad the proceeds of cryptocurrencies transactions completed in Korea

5. In accordance with Company Law, all South Korean companies must have **i)** 1 shareholder and **ii)** 1 director. Appointment of professional, passive [nominee shareholders](#) and [directors](#) (click links) and [bank signatory](#) enables our Client to **i)** sales invoice customers within 2 weeks and **ii)** sign contracts and lease premises;

Healy Consultants PLC will assist our Client to appoint the [nominee shareholder](#) and [director](#) as a **i)** [bank signatory](#) for Korean bank account and **ii)** account holder for crypto-currency exchange, our one-time fee amounts to US\$5,950. The annual nominee service fee will be paid independently and directly to the Korean nominee by our Client. Our estimate of annual nominee services fees will amount to US\$12,500;

6. In accordance with [Korea's Commercial Act](#), each entity must register for corporate tax and VAT at the Korea [National Tax Service](#);
7. For an active trading company, these [accounting and tax](#) fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants Group PLC will more accurately advise accounting and tax fees. For a dormant company, Healy Consultants Group PLC fees are only US\$950;



15. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients' will **not** have to travel during this engagement. Healy Consultants Group PLC will efficiently and effectively and aggressively complete company registration and corporate bank account opening in a timely manner without our Client presence. Additionally, there is 20% probability the Korean crypto currency exchange in-house Legal and Compliance Department will reject your crypto currency account application. In the unfortunate event this occurs, Healy Consultants will immediately discuss alternative crypto currency exchange solutions;

Korean crypto currency exchanges continue to tighten account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up to 5 weeks. Furthermore, Korean

crypto currency exchanges now require evidence of proof of business in the country where the the account will be, and supporting corporate documents;

17. If our Client requires nominee shareholder and director [services \(click link\)](#), Healy Consultants Group PLC will be pleased to assist. Our fee for professional, passive nominee corporate shareholder amounts to US\$2,100 per annum. Our fee to be both nominee director and shareholder amounts to US\$6,600 per annum. Being the sole shareholders and sole director of a Client's company exposes Healy Consultants Group PLC to reputation, litigation and financial risk;

18. If required, Healy Consultants Group PLC will be pleased to assist your firm to secure employee [visa](#) approvals. 19. Monthly, quarterly and mid-year Government tax obligations include monthly and quarterly payroll reporting, VAT and corporation tax return filing. If you need our help, Healy Consultants Group PLC can complete monthly Government reporting for a monthly fee of US\$860. Healy Consultants Group PLC monthly support will include **i)** receive in dropbox the monthly invoices from our client **ii)** label monthly bank statement transactions **iii)** preparation and submission of VAT returns and **iv)** submission of monthly employee payroll reporting;
