1. Healy Consultants Group PLC fees to efficiently and effectively complete Dominica PLC registration within 4 weeks by **i)** choosing the optimum regulatory license for our Client's business activities; **ii)** reserving a company name with [Dominica Company Register](#); **iii)** settling our accountant and lawyer fees; and **iv)** preparing a high quality company incorporation application for [Dominica Company Register](#);

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a [detailed project plan](#), mapping out [deliverables](#) by week throughout the engagement term;



Every week during the engagement, Healy Consultants Group PLC will email our Client a [detailed status update](#). Our Client is immediately informed of engagement problems together with solutions. In accordance with [Dominica Companies Act 1994](#), each Dominica company must appoint a company secretary, who may be a natural person or a body corporate, but the company secretary must be resident in Dominica. Healy Consultants Group PLC will act as your Dominica company secretary, for which our annual responsibilities include **i)** preparing and filing the legal annual return; **ii)** securely maintaining company records; **iii)** liaising with the Dominica government on our Client's behalf; **iv)** legal filing of changes of company structure; and **v)** reminding our Client of statutory deadlines;

In accordance with [Dominica Companies Act 1994](#), a Dominica shall as from the date of its incorporation have a legal registered office in Dominica, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group PLC's Dominica office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including **i)** tax letters; **ii)** notice of the legal annual return; and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants Group PLC's office address](#) on invoices, contracts, websites and business cards;

3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** reserving the company with [Dominica Company Register](#); **ii)** preparation of company articles of association; **iii)** legal verification of affidavit. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;
4. In accordance with Commonwealth of Dominica laws, each entity must register for corporate tax and VAT at the Direccion General de Impuestos Internos ([DGII](#));

It is a time consuming task, and Healy Consultants Group PLC will shelter our Client from the associated administrative challenges. Examples include New York, Germany, Liechtenstein, Austria, Bulgaria, South Africa, Australia, London, South America or Dubai. All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;

As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed company, when shareholders and directors and bank signatories reside overseas. Healy Consultants Group PLC will prepare a business plan for the bank to optimize the probability of corporate bank account approval. Depending on our Client's business and nationality, there is a 20% probability the banks will request a bank signatory to travel for a one-hour bank interview. Healy Consultants Group PLC will try its best to negotiate with the bank for a travel exemption. If our Client must travel to Dominica for corporate bank account opening, Healy Consultants Group PLC will refund our Client US\$ 950;

19. Monthly, quarterly and mid-year Government tax obligations include monthly and quarterly payroll reporting, VAT and corporation tax return filing.
