1. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. 6. In accordance with Namibia law, each entity must register for corporate tax and VAT at the [Receiver of Revenue](#), Ministry of Finance. Healy Consultants Group PLC will be happy to assist you with tax and VAT registration for a one-time fee of US\$750;
7. For an active trading company, these annual [accounting, audit and tax fees](#) are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual company accounting, audit and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants Group PLC will more accurately advise accounting and tax fees.
