Most of our Clients wish to place [Healy Consultants Group PLC's office address](#) on invoices, contracts, websites and business cards;
3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include: **i)** reserving the company name with the [Central Registry](#); **ii)** preparation of company deeds and articles of association; **iii)** registering the company with the [Central Registry](#) and **iv)** obtaining a company stamp. 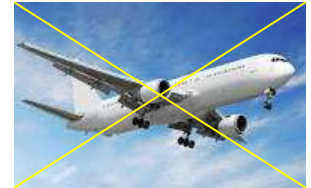

5. In accordance with [North Macedonia Tax Laws](#), every entity with annual turnover exceeding €17,000 must register for VAT with the [Public Revenue Office](#);
6. For an active trading partnership, these [accounting and tax](#) are an estimate of Healy Consultants Group PLC's fees to efficiently and effectively discharge annual accounting, audit and tax obligations. Following receipt of a set of draft accounting numbers from your entity, Healy Consultants Group PLC will more accurately advise accounting and tax fees. For a dormant entity, Healy Consultants Group PLC fees are only €950
7. All fees quoted in this invoice correspond to fees quoted [on Healy Consultants Group PLC's website](#). Please review this invoice carefully to identify errors.
